

SKAMANIA COUNTY, WASHINGTON

The water distribution system supplying Bender's Addition to the Town of North Bonneville, Washington, including all right, title and interest of the parties of the first part in and to the water main crossing Evergreen Highway and extending up Division Street. Also including all pipes, conduits, connections and fixtures forming a part of or addition to said distribution system. Also an easement along the southerlyline of Lots 20 and 26 inclusive of Block 1 of said Bender's Addition;

provided, that Whenever the pipe line is removed from said lots this easement shall terminate.

It is understood and agreed, That this conveyance does not cover the well and pump at one time used in connection with this system nor the pipe, fixtures and equipment situate upon the home property of the grantors in said addition.
