For a point of beginning commence at the intersection on the center line of Vancouver Avenue (sometimes called Cascades Road) with the center line of Kanaka Creek Road in section 36 tp 3 N R 7 E.W.M., thence northerly along the center line of said Kanaka Creek road a distance of 430 feet to initial point of tract to be conveyed; thence N 61° 40' E to center of Kanaka Creek, thence following the center of Kanaka Creek northerly to intersection with the south line of Stevenson Park Addition according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, thence west to intersection with the center line of the old survey of Strawberry road (now abandoned), thence westerly following the center line of said old survey of Strawberry road to intersection with the center line of Kanaka Creek Road, thence along the center line of Kanaka Creek Road in a southerly direction to the point of beginning, or initial point, of tract conveyed.
