## WARRANTY DEED

IN THE MATTER OF Secondary State Highway No. 8-B, Washougal River to McPhersons Stere.

KNOW ALL MEN BY THESE PRESENTS, That L. E. Allen and Ella A. Allen, husband and wife, of the County of Skamania, in the State of Washington, for and in consideration of the sum of One Thousand and Seven Hundred and no/100 (\$1700.00) Dollars, in hand paid, the receipt whereof is hereby acknowledged by the undersigned, do hereby and herein convey and warrant unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land containing 2 acres, more or less, in the NW1 of NW1, Section 9, Township 1 North, Range 5 East W.M., having widths as hereinafter set forth on each side of the following described center line of S.S.H. No. 8-B, as now located and of record in the office of the Director of Highways, at Olympia, Washington, to-wit:

Beginning at the point of intersection of the north boundary line, said section 9, with the center line of said S.S.H. No. 8-B, which point bears easterly of and distant 225.1 feet, measured along section line, from the northwest corner, said Section 9; thence along center line, said S.S.H. No. 8-B, S. 50°21' E., a distance of 91.7 feet, having a width of 60 feet on the northeasterly side and 30 feet on the southwesterly side of said center line; thence on the arc of a curve to the left, whose radius is 477.5 feet, a distance of 31.0 feet, having a width of 60 feet on the northeasterly side and 30 feet on the southwesterly side of said center line; thence continuing on the arc of said curve to the left, a distance of 50.0 feet, having a width of 50 feet on the northeasterly side and 30 feet on the southwesterly side of said center line; thence continuing on the arc of said curve to the left, a distance of 100 feet, having a width of 50 feet on the northeasterly side and 40 feet on the southwesterly side of said center line; thence continuing on the arc of said curve to the left, a distance of 50 feet, having a width of 60 feet on the northeasterly side and 40 feet on the southwesterly side of said center line; thence continuing on the arc of said curve to the left, a distance of 100 feet, having a width of 60 feet on the northeasterly side and 30 feet on the southwesterly side of said center line; thence continuing on the arc of said curve to the left, a distance of 72.9 feet, having a width of 50 feet on the northeasterly side and 30 feet on the southwesterly side of said center line; thence N. 81º11' E., a distance of 27.1 feet, having a width of 50 feet on the northerly side and 30 feet on the southerly side of said center line; thence continuing N. 81°11' E., a distance of 100 feet, having a width of 30 feet on each side of said center line; thence continuing N. 81º11' E., a distance of 539 feet, more or less, to an intersection with the easterly boundary line of the NW $\frac{1}{4}$  of NW $\frac{1}{4}$ , said Section 9, having a width of 30 feet on the northerly side and 40 feet on the southerly side of said center line; Excepting therefrom the area of the right of way for existing public roads contained therein.
