Private Right of Way and Tree Trimming Permit.

Know all men by these presents. That Chas. H. Shultz and Emma Shultz husband and wife of Stevenson State of Washington for and in consideration of One Dollars (\$1.00), receipt whereof is hereby acknowledged, hereby agrees to allow the West Coast Power Co., a Delaware corporation with principal offices at Portland, Ore., to construct and permanently maintain an Electric Power Line over, along and across the following described property, to-wit:
