I also say that I know of my own knowledge that that certain strip of land acquired by Columbia Valley Railroad Company under date of December 16, 1905, which deed is recorded in Book "I" of Deeds, pages 355-6, Records of Skamania County, Washington, as the same crosses Lot 4, Section 34, Township 3 North, Range 9 East of the Willamette Meridian, Skamania County, Washington, was entirely appropriated by the Portland and Seattle Railway Company in that certain case entitled Portland and Seattle Railway Company, petitioner, vs. Louis Gerlinger, Columbia Valley Railroad Company, Oregon Lumber Company, et al, No. 410, in the Superior Court of the State of Washington for the County of Skamania; the order of appropriation in said cause being filed January 3, 1908.

I further say that I know of my own knowledge that no flowage created by the backwater from the Bonneville Dam affects any of the land acquired by Alden Kingman, grantee in that certain deed from Skamania County, under date of June 20, 1935, and recorded in Book "Y" of Deeds, page 232, Records of Skamania County, Washington, all of said flowage being confined to the area south of the Spokane, Portland and Seattle Railway Company's right of way.

Murphy Donation Land Claim, Notification No. 837, Skamania County, Washington.
