D. L. Ramsay et ux to West Coast Power Co.

Private right of way and tree trimming permit

Know all men by these presents, That D. L. Ramsey and Daphne M. Ramsey of Stevenson State of Washington, for and in consideration of One Dollars (\$1.00), receipt whereof is hereby acknowledged, hereby agrees to allow the West Coast Power Co., a Delaware corporation with principal offices at Portland, Oregon, to construct and permanently maintain an Electric Power Line over, along and across the following described property, to-wit:

A tract of land containing one and seventeen-hundredths (1.17) acres located in the S. W.  $\frac{1}{4}$  of N. E.  $\frac{1}{4}$  - Sec. 36 Twp 3 North Range 7 $\frac{1}{2}$  E.W.M. Situated in Skamania County, Washington

and also agrees to allow the Power Company to cut down or trim any trees necessary to give proper clearance for said Power Line and install necessary guys and anchors, with the understanding that Power Company will pay for all damage done to crops, stock, or fences, caused by the exercise of the rights herein granted.

The rights, conditions and provisions of this permit shall inure to the benefit of and be binding upon the heirs, executors, administrators, successors and assigns of the respective parties hereto.
