W. E. Boeing et ux to Weyerhaeuser Timber Co.

Warranty Deed.

The Grantors, W. E. Boeing and Bertha Boeing, husband and wife at all times since September 27, 1921 of Seattle, Washington, in consideration of the sum of Ten Dollars (\$10.00) and other valuable considerations to them in hand paid, receipt whereof being hereby acknowledged, CONVEY and WARRANT to Weyerhaeuser Timber Company, a Washington corporation, Grantee, the following described real property situate in Skamania County, State of Washington, te-wit:

North Half of Northeast Quarter (N $\frac{1}{2}$  of NE $\frac{1}{4}$ ), Southeast Quarter of Northeast Quarter (SE $\frac{1}{4}$  of NE $\frac{1}{4}$ ) and Northeast Quarter of Southeast Quarter (NE $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of Section Eighteen (18), Township Nine (9) North, Range Five (5) East of W. M., containing 160.00 acres, more or less.

Subject to all of the conditions and reservations contained in the United States Patents to said lands and subject also to any easement of right of way in the public for any public roads heretofore established or now existing on said premises or any part thereof, and subject to the easement for road purposes over and across Section Eighteen (18), Township Nine (9) North, Range Five (5) East, W. M., granted by W. E. Boeing and Bertha Boeing, his wife, to Skamania County on June 9, 1931, and described as follows, to-wit:

A strip, piece or parcel of land forty (40) feet wide, on each side of the center line of the St. Helens National Forest Highway, as surveyed by the U. S. Bureau of Public Roads.

Said center line is more particularly described as follows:

Beginning at Sta. 195/68, a point on the center line at the intersection with the East boundary, Section Eighteen (18), Township Nine (9) North, Range Five (5) East, W. M., from which point the East quarter (1/4) section corner of said Section Eighteen (18) bears south fourteen hundred thirty (1430) feet distant;

Thence in a Westerly direction a distance of twenty-six hundred ninety (2690) feet, more or less, over and across and through the said Section Eighteen (18), to Sta. 222/58, a point on the center line at the intersection with the quarter (1/4) boundary of said Section Eighteen (18), from which point the center of said Section Eighteen (18) bears south thirteen hundred twenty (1320) feet distant.

Containing 4.9 acres, more or less.
