shall reduce or in any way affect the liability of the State for damage which may result from the construction and/or maintenance of the said highway, as elsewhere provided in this grant.

12. In all instances in which the Railway Company is herein authorized or may determine to do work, the expense of which is to be borne by the State, or suffers damage or incurs expense which under the terms hereof is to be borne by the State, the State shall reimburse the Railway Company for the expense or damage so incurred, including a reasonable amount for supervision and/or use of tools, promptly upon the rendition of proper bills therefor.

13. It is understood and agreed that the State shall take such measures as it reasonably can in all the circumstances to keep down and lay the dust upon said road by treating the same with oil or some other suitable substance at such intervals and times as it reasonable can do so.

14. The term "Superintendent of the Railway Company" as used herein shall include the Assistant Superintendent and his authorized assistants.

15. The State shall secure all necessary permits which may be required by any governmental authority, for the prosecution of the work to be done hereunder, and shall comply with all county, state and federal requirements.
