The Grantor E. M. Mann and Alice W. Mann, husband and wife, for and in consideration of Ten Dollars (\$10.00), and other valuable presents, in hand paid, CONVEY and WARRANT to E. L. Herron the following described real estate, situated in the county of Skamania, State of Washington:

A Portion of Lot 2 of the Ignaz Wachter Subdivision of a part of the West half of Northwest quarter of Sec. 36 Tp. 3 N. R. 7 E.W.M., as shown by the plat of said subdivision now on file in the Plat Book "A", page 30, of the records of the County Auditor of Skamania County Washington, said portion being described as follows, to-wit:
