dated December 22, 1937, for a franchise to construct, operate and maintain an electric transmission and distributing line upon a portion of P.S.H. No. 8 in Skamania County, Washington, for a period of fifty years.

Highway Franchise No. 626 - Granted and executed by Director of Highways at Olympia, Washington, dated Setember 29, 1931, for a franchise to construct, operate and maintain an electric transmission and distributing line upon a portion of State Road No. 8 (North Bank Highway) in Skamania County, Washington, for a period of fifty years.

Permits and Easements

Permit dated November 3, 1937, for an electric power line, consisting of two wires carrying 2300 volts, to be placed over and across the right of way and track of the Railway Company at a point in the southeast quarter of Section 36, Township 3 North, Range 8 East, W. M., near Collins, Skamania County, Washington said point being designated as engineer's station 1273+87.6.

Permit dated November 3, 1937, for an electric power line, consisting of two wires carrying 2300 volts, to be placed over and across the right of way and track of the Railway Company at a point in Lot 1 of Section 32, Township 3 North, Range 9 East, Willamette Meridian, near Sepsecan, Skamania County, Washington, said point being designated as engineer's station 1183+48.5.

Permit dated December 3, 1936, for an electric line, consisting of three wires carrying 115/230 volts, to be placed over and across the right of way and tracks of the Railway Company at a point 1,130 feet easterly of the easterly end of Bridge No. 54.2 fast of Stevenson, in Skamania County, Washington.

Permit dated 1936 for an electric transmission line, consisting of two wires carrying 2300 volts, to be placed over and across the right of way and track of the Railway Company at a point designated as engineer's station 1229+34.3 in Section 31, Township 3 North, Range 9 East, W.M., at Collins, Washington, said transmission line to be supported by one pole and two anchors upon the northerly side of said right of way. Total annual rental of \$4.50 payable annually in advance, beginning with December 1, 1936.

Permit dated November 26, 1937, for an electric power line, consisting of two wires carrying 2300 volts, to be constructed upon and across the Railway Company's property in that portion of Lot 4, Sedtion 35, Township 3 North, Range 8 East, Willamette Meridian, Skamania County, Washington, lying north of the State Highway, said power line to cross said property in an easterly and westerly direction and to be supported by two poles to be placed upon said property. Total annual rental payable in advance beginning with December 1, 1937-\$3.00.

Permit from U. S. War Department to Columbia River Light & Power Company (predecessor of West Coast Power Company), dated June 16, 1921, to construct and maintain a line of wires for transmission of electricity across the Columbia River at about 1/4 mile west of Cascade Locks, Oregon.

Wire Line Agreement, Dept. No. R-1593-B, dated June 13, 1938, by and between Oregon-Washington Railroad & Navigation Company, an Oregon corporation, and its Lessee, Union Pacific Railroad Company, for the right to construct, maintain and operate an electric power transmission line, consisting of twenty-seven poles, nine anchors and the necessary wires and appurtenances upon, over, along and across the property of the Railroad Company, at or near Collins, Skamania County, Washington. Annual rental payable in advance - \$5.00.

Permit for Attachments for Skamania County Telephone Company to place attachements on crossarms or poles of West Coast Power Company in Stevenson and Carson, Skamania County, Washington. Total annual rental - \$17.80.

Agreement dated August 8, 1931, granting permission to the Northwestern Electric Company to place and maintain on the poles of West Coast Power Company wires and appliances, located on North Bank Highway east of east corporate limits of the Town of Stevenson, Washington. Annual rental charge of Fifty cents (50¢) for each attachment.

Letter dated August 24, 1936, from Northwestern Electric Company granting permission to the West Coast Power Company to extend secondaries and to contact Northwestern Electric Company Pole #283, by attaching two double-arm fixtures. Rental charge for these attachments shall be eighty cents (80¢) until January 1, 1937, and eighty cents (80¢) annually thereafter. This letter refers to and is included with above Agreement, dated August 8, 1931.

<u>Permit</u> for attachments dated November 3, 1938, granting permission to West Coast Power Company to place attachments on crossarms or poles of Oregon-Washington Telephone Company in Stevenson and Carson, Skamania County, Washington. Annual rental - \$1.60.

Agreement dated August 16, 1938, whereby Northwestern Electric Company grants to West Coast Power Company permission to attach one crossarm with appurtenances on Pole No. 190 of the Condit-Camas 66 Kv. transmission line, described pole located On Government Lot no. 3, Skamania County, Washington. Annual rental payable in advance on January First each year - \$0.80.

Agreement dated November 6, 1937, whereby Northwestern Electric Company grants to West Coast Power Company permission to attach one support for an overhead suspension street light on pole No. 298 located twelve feet west of the southwest corner of the intersection of Second and Russell Streets of said town of Stevenson, Skamania County, Washington. Annual rental payable in advance on January First each year - \$0.80.

Agreement for Pole contacts dated October 15, 1933, granting permission to the North Bank Stages to attach to poles of West Coast Power Company a signal line
