Witnesseth; that said parties of the first part, for and in consideration of the sum of Ten Dollars and other good and valuable considerations, lawful money of the United States, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents, GRANT, BARGAIN, SELL, CONVEY and CONFIRM unto the said party of the second part, and to his heirs and assigns, the following described tracts or parcels of land situate in the County of Skamania, State of Washington, and more particularly bounded and described as follows, to-wit:

The Southwest quarter of the Northeast quarter and the West half of the Southeast quarter of Section 20; and the west half of the West half of said Section 20, all in Township 3 N., Range 10 EWM, in Skamania County, Washington; SAVE and EXCEPT therefrom all rights-of-ways or easements for roads or roadways as heretofore established and now traveled over and across said premises and also excepting easements or rights-of-ways heretofore granted for electric transmission lines and telephone lines.
