To all to Whom these presents shall come, Greeting:

Whereas, John Clarkson of Klickitat County, Washington, has deposited in the General Land office of the United States a certificate of the register of the Land office at Vancouver, Washington, whereby it appears that full payment has been made by the said John Clarkson according to the provisions of the Act of Congress of the 24th of April, 1820, entitled, "An act making further provision for the Sale of the Public Lands," and the acts supplemental thereto, for the

The Southeast quarter of the South East quarter of Section Ten in Township Three North of Range Ten East of Willamette Meridian in Washington containing forty acres.

according to the Official plat of the survey of the said Land, returned to the General Land Office by the Surveyor General, which said tract has been purchased by the said John Clarkson

Now, Know Ye, That the United States of America, in consideration of the premises, and in conformity with the several Acts of Congress in such case made and provided, have given and granted, and by these presents do give and grant, unto the said John Clarkson, and to his heirs, the said tract above described;

To Have and To Hold the same, together with all the rights, privileges, immunities and appurtenances, of whatsoever nature, thereunto belonging, unto the said John V Clarkson, and to his heirs and assigns, forever, subject to any vested and accrued water rights for mining, agricultural, manufacturing or other purposes, and rights to ditches and reservoirs used in connection with such water rights as may be recognized and acknowledged by
