In Testimony Whereof, I, Grover Cleveland, President of the United States of America, have caused these letters to be made Patent, and the seal of the General Land Office to be hereunto affixed.

Given under my hand, at the City of Washington, the twentieth day of June, in the year of our Lord one thousand eight hundred and ninety-three, and of the Independence of the United States the one hundred and seventeenth.

Know all men by these presents that we, John Clarkson and Elisabeth Clarkson his wife in consideration of \$1⁰⁰ to us in hand paid by the White Salmon Boom & Improvement Co. a corporation duly organized and existing under and by virtue of the laws of the State of Washington, the receipt whereof is hereby acknowledged have given, granted, bargained, sold and conveyed and do hereby given, grant bargain sell and convey unto the White Salmon Boom & Improvement Co., aforesaid and unto its successors and assigns forever, the right to use the bed of the stream known as the White Salmon River together with a strip of land one hundred feet wide on each side of said stream, measuring from the ordinary line of high water along the bank of said river where it flows through the following described land in Klickitat and Skamania Counties, Washington to wit:

The South east quarter of the Southeast quarter of section ten (10) township three (3) North Range ten (10) East.

It is intended to convey to the said White Salmon Boom and Improvement Co. the right to use the above described property for all purposes necessary or convenient in floating logs timber and timber products in said river including the right to build and maintain dams booms and piers. But the White Salmon Boom and Improvement Co. is not to fence said
