Torpen of Skamania County State of Washington, have bargained and sold, and by these present do grant, bargain, sell and convey unto said B. E. Torpen his heirs and assigns, all the following bounded and described real property, situated in the County of Skamania and State of Washington:

The North Half of the Southeast Quarter of the Northwest Quarter; the West Half of the Northwest Quarter of the Southwest Quarter of the Northeast Quarter; the South Half of the Southwest Quarter of the Northeast Quarter of the Northwest Quarter and the South Half of the North Half of the Southwest Quarter of the Northeast Quarter of the Northwest Quarter of Section 10, Township 2 North of Range 7 East of Willamette Meridian, together with all rights of way and/or easements over and across any and all of the adjacent lands.

Excepting therefrom all that part of said property covered by Blue Lake, its immediate shore line, and a strip of land 200 feet wide adjacent to and paralleling the shore of said Blue Lake, and reserving to these grantors and their assigns the right to remove any and all rock located on any part of the property above described and further reserving to these grantors and their assigns, the right of ingress and egress for the purpose of removing said rock at all times.
