DECLARATION OF HOMESTEAD

KNOW ALL MEN BY THESE PRESENTS: That I, David D. Higgins, do hereby declare that I am the head of a family; that I am married, and the name of my wife is Bertha Higgins; that my family consists of my said wife and one minor child, Doris Higgins.

That I am at the time of making this declaration, actually residing, with my family, on the premises hereinafter described, and that I claim said premises as a homestead.

The premises so claimed by me are the real property, situated in the County of Skamania, State of Washington, described as follows:

Commencing at the Southwest corner of Lot 9 of Normandy tracts, according to the official plat thereof on file and of record in the office of the County Auditor, Skamania County, Washington, thence South 54° 45' W. along the northerly line of the highway a distance of 468 feet to the initial point of the tract hereby conveyed; thence at right angles North 35° 15' West 50 feet; thence at right angles South 54° 45' West (parallel to Highway) 25 feet; thence at right angles S35° 15' East 50 feet to the North line of highway; thence North 54° 45' East to point of beginning, together with the dwelling house thereon, and its appurtenances.
