EASEMENT

FOR AND INJCONSIDERATION of the sum of One Hundred Dollars (\$100.00), payable at the rate of Twenty Dollars (\$20.00) per year in advance, the Grantors, Ruth Birkenfeld and Frank Birkenfeld, her husband, convey and grant to T. A. Ryan, his heirs and assigns, for a period of five years an easement for road purposes over and along the following described strip of land in Skamania County, Washington:

A right of way approximately forty (40) feet wide, center line of same being described as follows: and as now located and staked out on the ground:

Commencing at the Northwest corner of the Wm. M. Murphy Donation Land Claim, thence East along North boundary of said D.L.C. a distance of 450.2 feet; thence South 14° 15' W a distance of 50.5 feet to point of beginning; thence S 61° 45' E. a distance of 76.6 feet; thence, on a 100° curve to the right with a radius of 65.2 feet for a distance of 86.0 feet through an angle of 86°00'; thence S 24°15' W a distance of 16.8 feet; thence on a 6°15' Curve to the left with a radius of 917.2 feet for a distance of 100.0 feet through an angle of 6°15'; thence S. 18° W a distance of 26.4 feet; thence on a 60° curve to the left with a radius of 100.0 feet a distance of 93.3 feet through an angle of 56°00'; thence S 38°00' E a distance of 15.3 feet; thence on a 40° curve to the right with a radius of 146.2 feet for a distance of 52.5 feet through an angle of 21°00'; thence S 17° E a distance of 3.7 feet through an angle of 46°00'; thence S 63° E a distance of 36.4 feet; thence on 50° curve to left with a radius of 100.0 feet a distance of 50° curve to left with a radius of 118.3 feet for a distance of 36.4 feet; thence N 59° E a distance of 45.2 feet; thence on a 20° curve to the left with a radius of 287.9 feet a distance of 100.0 feet through an angle of 20° 00'; thence N 39°00' E a distance of 67.5 feet more or less to Lateral Highway #7.
