YAKIMA BINDERY & PTO., CO., 193234

Commencing at the 1/4 Corner to Sections 14 and 23, Township 3 North, Range 8 East, thence South a distance of 160 feet to the point of beginning; thence in a westerly and south-westerly direction following a road center line as now staked a distance of 1565 feet more or less to an intersection with Lateral Highway #7.

All debris from right of way to be burned, so there will be no fire hazard.

It is understood and agreed that the Fifty Dollars (\$50.00) rental provided for above shall be paid in the following manner: Twenty-five Dollars (\$25.00) to be paid on the date of the signing of this instrument and Twenty-five Dollars (\$25.00) to be paid not later than October 31, 1938.

At the end of the five year period and in the event the Grantee still has use for the above described roadway, it is understood that said easement may be extended and renewed from year to year upon the payment by the Grantee, in advance, of the same yearly rental herein provided for: to-wit \$10.00.
