Buslach and Alyce Buslach his wife, of the County of Skamania in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of Ten and 00/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged, ha\_granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land 100 feet wide (except as may be hereinafter specified), being 50 feet wide on the northeastward side and 50 feet wide on the southwestward side of the center line of said highway as surveyed over and across the  $SW_{\frac{1}{2}}SW_{\frac{1}{2}}$  of Section 4, Township 1 North, Range 5 E.W.M., excepting tright of way of existing highway. Grantee shall provide an approach to a private road when constructed by grantors at about Engineering Survey Station 660+00
