THIS AGREEMENT, Made this 1st day of May, 1940, between Karl J. and Lillian M. Drus, hus band and wife, hereinafter called the sellers, and Nina M. Hoskins, hereinafter called the buyer.

WITNESSETH, That in consideration of the stipulations herein contained, and the payments to be made as hereinafter specified, the sellers agree to sell unto the buyer, and the buyer agrees to purchase from the sellers the following described real property situated in the County of Skamania, State of Washington, and more particularly known and described as follows, to-wit:

It being intended to convey any rights to the center of the Washougal River not conveyed by the original plat now of record in the above said county and state.

for the sum of Seventeen Hundred and Fifty Dollars (\$1750.00) on which the buyer has paid the sum of Four Hundred Dollars (\$400.00), the receipt whereof is hereby acknowledged.

And the buyer, in consideration of the premises, hereby agrees to pay to the sellers at Portland, Oregon (or to the Main Branch of the United States National Bank at Portland, Oregon, for the sellers' account, if the sellers, or either of them, shall in writing request payments to be made at said bank) the remaining principal with interest at 6% per annum, at the times and in the manner following: On and commencing July 1, 1940, the sum of Twenty Dollars (\$20.00) or more, including interest, and thereafter the sum of Twenty Dollars (\$20.00) on the first day of each and everymenth until the full sum of principal and interest has been paid.
