P. Lewellen on December 22, 1938 for a ten year period over the NET of NET of said Section 21; the right of way being thirty feet in width for the construction of a logging road. In said agreement Mr. Lewellen grants to us, our heirs and assigns the right to use his said private logging road for use in moving timber we now own in said Section 21 to the junction with the County road, provided we assist in maintaining the road.
