WHEREAS, The parties hereto are the owners of the Southeast (SE $\frac{1}{4}$ ) of Section Twenty-<sup>Three</sup> three (23), Township/(3) North of Range Eight (8) East of the Willamette Meridian in equal undivided interest, and

WHEREAS, they desire to partition the same in the manner hereinafter specified.

THEREFORE, KNOW ALL MEN BY THESE PRESENTS, That the party of the first part does Convey and Warrant unto the parties of the second part an undivided one-half interest in and to the N $\frac{1}{2}$  of the SE $\frac{1}{4}$  of said Section 23, Tp. 3 N. R. 8 E. W. M., thereby vesting in said parties of the second part full and complete title thereto.

And the parties of the second part do hereby Convey and Warrant unto the party of the first part the S $\frac{1}{2}$  of the SE $\frac{1}{4}$  of said Section 23, Tp. 3 N. R. 8 E. W. M., excepting that part occupied by the Transmission line of the Bonneville Project, vesting in the party of the first part full and complete title thereto.
