ACCESS ROAD EASEMENT

Tract No. BC-AR-4 Parcel 1

FOR AND IN CONSIDERATION of the sum of Twenty-five Dollars (\$25.00) in hand paid, receipt of which is hereby acknowledged, I, Lyn Arnold, a bachelor, have granted, bargained and sold and by these presents do hereby grant, bargain, sell and convey unto the UNITED STATES OF AMERICA and its assigns, a permanent easement and right-of-way approximately 14 feet in width, with such additional widths as are necessary to provide for cuts, fills and turnouts and for curves at the angle points, all over and across the lands of the undersigned in Government Lot 4, the SW1 of the NW1, and the NW2 of the SW1 of Section 2, and all that portion of the Felix G. Iman D. L. C. No. 44 in Section 2 lying south of the east and west center section line of said Section 2, all in Township 2 North, Range 7 E. W. M., Skamania County, Washington, for the following purposes, namely: the right to enter and to clear of timber, endangering trees, and brush; to grade, level, cut, fill, drain, build, maintain, repair and rebuild a road or highway and such culverts, bridges, turnouts, retaining walls or other appurtenant structures as may be necessary, on, over and across the land embraced within the right-of-way, the center line of which is described as follows:
