EASEMENT DEED

McGowan & Sons, Inc., a corporation, to remove brush, trees, and structures from the real property hereinafter described, does hereby grant and convey unto John Kraetch, a bachelor, his heirs and assigns, and P. J. McGowan & Sons, Inc., a corporation, its successors and assigns, hereinafter called the grantees, a perpetual easement over and upon the following described parcel of land, to-wit:

A parcel of land being all that portion of the $N_2^{\frac{1}{2}}$ $NW_4^{\frac{1}{4}}$; and the $SW_4^{\frac{1}{4}}$ $NW_4^{\frac{1}{4}}$ in Section 20; and the $S_2^{\frac{1}{2}}$ $NE_4^{\frac{1}{4}}$; and the $NE_4^{\frac{1}{4}}$ $SE_4^{\frac{1}{4}}$ of Section 19, all in Township 2 North, Range 7 East, W.
