A. Simmons and Louanna Simmons, his wife, have owned and have occupied said premises as their home in the continuous, open and adverse possession thereof.

Mary J. Inman, my former wife, died shortly after the execution of the above mentioned deed to R. F. Inman leaving as her sole heirs at law: R. F. Inman, Louanna Inman Simmons, May Inman Standsbury, Kenneth Inman and Edna Inman Dodson, all of whom have been of age for more than ten years.
