A strip of land 400 feet in width off the Westerly side of that portion of Lot 1 Section 22 Township 3 North Range 10 East W. M., which extends Southerly from the top or edge of the main bluff to the Columbia River and more particularly described by metes and bounds as follows:

Commencing at the meander corner between Sections 21 and 22, Township 3 North Range 10 E of the Willamette Meridian on the right bank of the Columbia River; thence North 00° 50' E. 1209.50 feet along the West line of said Lot 1 to the edge of the main bluff in said Lot 1; thence following the edge of the main bluff in said Lot 1 in an Easterly direction as follows:
