WARRANTY DEED.

The Grantor, Charles Kane, an unmarried man, of Stevenson, Washington, for and in consideration of the sum of Ten Dollars and other valuable considerations, in hand paid, receipt whereof is hereby acknowledged by the Grantor, does hereby WARRANT and CONVEY to Fred Walz, John Walz and Fred Walz, Jr., the Grantees herein, the following described real property, to-wit:

The North-east Quarter (NE $\frac{1}{4}$) of Section Twenty-five (25) in Township Three (3) North of Range Seven (7), East Willamette Meridian; excepting therefrom the tracts of land mentioned as follows, to-wit:
