In case the vendee makes the payments above specified at the time and in the manner aforesaid, and pays said taxes before delinquency, the vendor will make and deliver to the vendee a good and sufficient warranty deed for said premises; but in case of default in the payment of said sums of money or any installment thereof,/in case of failure to pay said taxes before delinquency, the vendor may, at her option, terminate this agreement and take possession of said premises, and in such event all rights hereunder shall be terminated and all sums of money paid hereon shall be forfited to the vendor as liquidated damages.
