That the parties of the first part for and in consideration of the sum of one dollar to them paid, do hereby GRANT, BARGAIN, SELL and CONVEY unto the party of the second part the following described real property in Skamania County, Washington, to-wit:

Beginning at the intersection of the east line of the SW $\frac{1}{4}$  of the SW $\frac{1}{4}$  sec. 29 twp. 3 N. R. 8 E. W. M., with the south line of State Highway No. 8 (also known as U. S. Highway 830) running thence South 340 feet; thence in a Southwesterly direction 275 feet to a point 340 feet due South of the South line of said Highway; thence North 340 feet to the South line of said Highway; thence following the Southerly line of the said Highway in a Northeasterly direction to the point of beginning, containing two acres more or less.
