This agreement made and entered into by Marcus Norman Davey and Gladys R. Davey, husband and wife, parties of the first part, between Myrtle E. Hildenstab, party of the second part, witnesseth:

That the parties of the first part agree to execute and deliver to the party of the second part Warranty Deed to the following described property in Skamania County, Washington to-wit:

Commencing at the Northwest corner of the East half of the Northwest quarter of the Northeast quarter of Section 28, Tp. 3 N. R. 8 E.W.M., thence East 181 feet; thence South 261 feet; thence West 181 feet; thence North 261 feet to the point of beginning; reserving and excepting however an easement for road purposes along a strip of land 15 feet in width along the Westerly line thereof.

upon paying the purchase price of \$300.00, provided that the parties of the first part shall furnish to the party of the second part either policy of title insurance of abstract of title showing merchantable title in the parties of the first part free and clear of encumbrances, and shall move upon said property the cabin that was removed therefrom by the parties of the first part, and place the same upon said property in satisfactory condition.

This agreement shall be executed by the parties hereto within fifteen days from the date hereof.
