KNOW ALL MEN BY THESE PRESENTS, That Geo. F. Christensen, and Minnie M. Christensen, his wife, of the County of Skamania, in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of Forty-Five and no/100 (\$45.00) Dollars, in hand paid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

All that portion of Govt Lot 14, the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of NE $\frac{1}{4}$ Section 1, Twp 3 North, Range 7 $\frac{1}{2}$ East, W. M; and lying Northeasterly of a line drawn parallel to and distant 30 feet, measured at Right Angles Southwesterly from center line of SSH.8-C; Carson to Forest Boundary; EXCEPTING therefrom all lands which may have been heretofore conveyed for road and highway purposes;

The above described lands for R/W contain 0.10 acres, more or less; the specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia and bearing date of approval June 3rd, 1941

TO HAVE AND TO HOLD the same, unto the State of Washington forever.
