- 2. That the said perpetual easement and right-of-way be and the same is hereby deemed to have been condemned and taken for the use of the United States of America as of the date of the filing of the declaration of taking and the depositing of the sum of \$3,538.00 in the registry of this Court, to-wit, as of the 15th dayof August, 1941, and the right to just compensation for said perpetual easement and right-of-way, together with the right to fell, limb or top certain danger trees adjacent thereto, is hereby vested in the persons entitled thereto, and the amount of said compensation shall be ascertained and awarded in this proceeding and established by judgment herein pursuant to law.
- 3. That the land referred to in this decree, in, to and upon which the United States is given the perpetual easement and right-of-way hereinbefore described, is situated in Skamania County, Washington, and is bounded and described as follows, to-wit:

Tract BC-5B:
A parcel of land being all that portion of the NEt NEt of Section 16, Township 2 North, Range 7 East, W. M., Skamania County, Washington, which lies within a strip of land 300 feet in width, of which 212.50 feet lie on the westerly side of and 87.50 feet lie on the easterly side of the Bonneville-Coulee transmission line survey;

Said survey line being located as follows: Beginning at a point which is the intersection of said survey line with the west line of the NEt NEt of said section 16, said point being 347.35 feet south and 1327.87 feet west of the northeast corner of Section 16, Township 2 North, Range 7 East, W. M.; thence running N. 39° 40' 18" E. a distance of 446.90 feet to a point which is the intersection of said survey line with the south line of the SEt of Section 9, Township 2 North, Range 7 East, W. M., said point being S. 89° 48' 55" W. along said south line a distance of 1371.92 feet from the southeast corner of Section 9, Township 2 North, Range 7 East, W. M.

Said parcel contains 2.20 acres, more or less.
