THE GRANTORS, N. O. Anderson and Christine Anderson, husband and wife, in consideration of the sum of one dollar to them paid, do hereby Convey and Warrant unto Robert Bennett and Thelma Bennett, husband and wife, grantees the following real property in Skamania County, Washington, to-wit:

Commencing at the southwesterly corner of Lot 6 of Normandy Tracts, according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington at page 82 Plat Book "A", thence northwesterly along the westerly line of said Lot 6 a distance of one hundred (100) feet to the initial point of this description; thence continuing from said initial point along the westerly line of said Lot 6 a distance of 117.8 feet to the northwesterly corner of said Lot 6, thence at right angle in a northeasterly direction along the north line of said Lot 6 a distance of sixty (60) feet, thence at right angle in a southeasterly direction a distance of 217.8 feet to the southerly line of said Lot 6, thence in a southwesterly direction along the said southerly line a distance of ten (10) feet, thence at right angle in a northwesterly direction, parallel to the westerly line of said Lot 6 a distance of one hundred (100) feet, thence at right angle in a southwesterly direction a distance of fifty (50) feet to the place of beginning.

Excepting and reserving an easement for pipe line across the said property as now located, with right of ingress and egress to repair and maintain said pipe line.
