E½SW¼ and S½SE¼ of Section 23, Township 4 North, Range 9 East, Willamette Meridian;

TO HAVE AND TO HOLD the same together with all and singular the tenements, hereditaments, and appurtenances thereunto belonging or in anywise appertaining, to the said Harold J. Broughton, D. M. Stevenson and A. T. Fraley and to their heirs, executors, administrators and assigns forever.
