Gladys Hinds et vir to Alfred A. Aya et ux

Agreement to camcel certain spring rights and to change certain words in road right-of-way.

This agreement, entered into by and between Gladys Hinds (formerly Gladys Guptill) and Ralph H. Hands, her husband, and Alfred A. Aya, and Grace H. Aya his wife, Witnesseth: That,

Referring to a certain grant from said Gladys Guptill to said Alfred A. Aya, in Sections 24 and 25 in Township 2 North, Range 6 E. W. M., Skamania County, Washington, dated July 27th., 1934 and recorded July 31, 1934, in Book X of Deeds at page 576 Records of said County, it is hereby agreed between the parties hereto, in consideration of One (\$4.00) Dollar, paid each to the other receipt whereof is hereby acknowledged, that the provisions and conditions in said grant appertaining to the use of certain springs and the building and maintenance of a certain reservoir, shall be and the same are hereby cancelled and made void; also, that where the words "also a perpetual right of way for road purposes, beginning at or near the southeast corner of said ot 11, and extending in a general northwesterly direction across the E_a st end of said E_a^1 of said Lot 11, and in a general northwesterly direction across the S2 of the SE4 of the SW4 of Section 24" appear in said grant, that the word "southeast" shall be and the same is hereby changed to read "northeast", and the words "in a ageneral northwesterly direction across the east end of said Ez of said Lot 11, and" shall be and the same are hereby cancelled and eliminated from said grant; also, that the road right of way across the S2 of SE4 of SW4 of said Section 24, in said grant shall be confined approximately to the route now used by said grantee, except at points on said route where easier grades may be available, in which case said route may be changed to such easier grades, provided, that when such changes shall be made and the roadway finally improved, all other routes shall be regarded as abandoned; and the grantors and grantee_, their heirs and assigns, shall have the right to the use of said roadway on the terms and conditions as set out in said grant.

This agreement shall be binding upon the heirs and assigns of the parties hereto.
