(1) H. E. Survey No. 232, embracing a portion of Section twenty-five in Township four north of range seven east of the Willamette Meridian, Washington, more particularly bounded and described as follows: Beginning at corner No. 1, from which the Southwest corner to said Section twenty-five, bears north eighty-nine degrees forty-five minutes west five and eighty-four-hundredths chains distant; thence, north eighteen degrees thirty-two minutes west ten and sixty-three-hundredths chains to corner No. 2; thence, north forty-eight degrees west three and eighty-three-hundredths chains to corner No. 3; thence, north thirty minutes west twelve and seventy-six-hundredths chains to corner No. 4; thence south seventy degrees four minutes east twelve and forty-one-hundredths chains to corner No. 5; thence south forty degrees seventeen minutes east twenty-seven and eighty-five-hundredths chains to corner No. 6; thence north eighty-nine degrees forty-five minutes west twenty-three and thirty-one-hundredths chains to corner No. 1, the place of beginning, containing forty-one and six-hundredths acres.
