forest lands and requested a conveyance thereof by said Skamania County to the State Forest  
Board for said purpose, NOW, THEREFORE,

Under and by virtue of the Laws of the State of Washington empowering the counties of  
said state to make conveyance of properly designated lands to the State Forest Board of said  
state for state forest lands, therefore,

BE IT RESOLVED by the county commissioners of Skamania County, Washington, now in formal  
and regular session, that conveyance by a good, sufficient and proper deed be made to the State  
Forest Board of the State of Washington, in accordance with Chapter 154, Laws of 1923 and  
statutes amendatory thereof and supplemental thereto, and Chapter 126 of the Laws of 1935, of  
the above described lands and that the chairman of said board be authorized to execute such  
deed of conveyance.

John Franz, being first duly sworn on oath deposes and says: I am the same person as  
the grantee named in that certain deed dated November 8, 1911, recorded November 8, 1911,  
page 350 Book "N" of Deeds, records of Skamania County, Washington, covering the South half  
of North half of Southeast quarter of Southeast quarter Section 32, Tp. 2 N. R. 6 E. W. M.,  
and in deed dated March 10, 1914 recorded March 10, 1914, at page 558 Book "O" of Deeds,  
records of said County, covering North half North half of Southeast quarter of Southeast  
quarter, Section 32, Tp. 2 N. R. 6 E. W. M., in both of which deeds one Felix Horst was gran-  
tor. At the date of said deeds I was a married man and Marie Franz was my wife. The said  
Marie Franz died August 22, 1922, leaving surviving her the following children, to-wit: Mae  
Franz, now Hadley; Ruby Franz; Margaret Franz, now Pearson; and Elizabeth Franz, who were  
the only children the issue of her body.
