COUNTY DEED
FOR ACCESS ROAD EASEMENT

SKAMANIA COUNTY, a municipal corporation of the State of Washington, acting by and through its Board of County Commissioners, in consideration of the premises and by virtue of the statutes of the State of Washington, in such cases made and provided, and A. A. AUSPLUND and MILDRED G. AUSPLUND, husband and wife, contract purchasers, for and in consideration of the sum of Ten Dollars (\$10.00), cash in hand paid, receipt of which is hereby acknowledged, do hereby grant and convey unto the UNITED STATES OF AMERICA and its assigns, a permanent easement and right-of-way approximately 14 feet in width, with such additional widths as are necessary to provide for cuts, fills and turnouts and for curves at the angle points, all over and across the lands of the undersigned in

The East half of the Northwest Quarter of Section 18, Township 3 North of Range 10 East, Willamette Meridian, Skamania County, State of Washington,
for the following purposes, namely; the right to enter and to clear of timber, endangering trees, and brush; to grade, level, cut, fill, drain, build, maintain, repair, and rebuild a road or highway and such culverts, bridges, turnouts, retaining walls, or other appurtenant structures as may be necessary on, over and across the land embraced within the right-of-way, the center line of which is described as follows:

Beginning at survey station 1101+13.70, a point on the survey line of the Bonneville Power Administration's Bonneville-Coulee Transmission Line, said point being S. 0° 10' 10" W. a distance of 511.97 feet from the one quarter section corner on the north line of Section 18, Township 3 North, Range 10 East, Willamette Meridian; thence S. 4° 28' 00" W. a distance of 186.14 feet; thence S. 3° 11' 00" E. a distance of 256.00 feet; thence S. 3° 31' 00" E. a distance of 462.99 feet; thence S. 3° 24' 00" W. a distance of 269.70 feet; thence S. 17° 26' 00" E. a distance of 91.34 feet; thence S. 1° 14' 00" E. a distance of 184.97 feet; thence S. 21° 42' 00" W. a distance of 59.00 feet; thence S. 5° 06' 00" E. a distance of 204.02 feet; thence S. 14° 28'
