KNOW ALL MEN BY THESE PRESENTS that Nels Brenholm, a widower, individually and as administrator of the estate of Gussie Brenholm, also known as Augusta Brenholm, deceased, party of the first part, in consideration of the sum of Eight Hundred Dollars to him in hand paid does hereby CONVEY and WARRANT unto George H. Hathaway and Viola Hathaway, husband and wife, parties of the second part, the following described real property in Skamania County, Washington, to-wit:

Commencing at the southwest corner of Lot One of Stevenson Park Addition according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington, thence northerly along the west line of said Lot One 170 feet, thence northeasterly at right angles to said west line of Lot One to the center of Kanaka Creek, thence southeasterly along the center of Kanaka Creek, to the south line of said Lot One, thence westerly along South line of Lot One to the place of beginning, containing one acre, more or less. Also:

Commencing at the southwest corner of the above mentioned Lot One, thence southerly along Kanaka Creek Road to intersection with the north line of Strawberry Road as originally surveyed and located, thence northeasterly along the north line of said Strawberry Road to an intersection thereof with the south line of the above mentioned Lot One, thence west to the place of beginning, containing one fourth acre, more or less; situated in the County of Skamania, State of Washington.
