paid thereon by way of rentals for the use and occupation of the premises and by way of liquidated damages because of the vendees' breach of this agreement, or the vendors may sue for the balance of the purchase price.

It is further understood and agreed between the vendors and the vendees that any be buildings or improvements placed upon the above described real property shall become a part of the real property when such buildings are so built or any improvements are so made, and it is further understood and agreed that the vendées will not allow any liens to accumulate or be filed against this property, and if any liens are filed or any accumulate against the property, that this shall be considered to be a breach of the terms of this contract.

It is further understood and agreed that in case it becomes necessary to maintain action to enforce collection of the payments due or to repossess the property, that a reasonable attorney's fee may be allowed in addition to the costs of such action.
