Burns, Director grant to Pacific Power & Light Company, a Maine corporation, a perpetual right-of-way in and over the following described real property situated in the County of Skamania, State of Washington, to-wit:

Beginning at a point on the South line of the County Road, 300 feet South of the Northwest corner of the Northwest one-fourth of the Northeast one-fourth of Section 30, Township 2 North of Range 5 East of the Willamette Meridian and running thence East along the South line of said County Road 209 feet; thence South 627 feet; thence West 209 feet to the West line of said Northwest one-fourth of said Northeast one-fourth of said Section 30, then North along said line 627 feet to the place of beginning, containing 3 acres more or less.
