For and in consideration of the sum of Sixty Five Dollars (\$65.00) in hand paid, receipt of which is hereby acknowledged, we, M. Louise Thomas and Alice I. Thomas, owners of equal interest, as our separate property, have granted, bargained, and sold and by these presents do hereby grant, bargain, sell, and convey unto the United States of America and its assigns, a permanent easement and right-of-way approximately 14 feet in width, with such additional widths as are necessary to provide for cuts, fills, and turnouts and for curves at the angle points, all over and across the lands of the undersigned in

The Northwest Quarter, and Lot 3, all in Section 6, Township 1 North of Range 6 East, W. M., situate in the County of Skamania, State of Washington.

for the following purposes, namely: the right to enter and to clear of timber, endangering trees, and brush; to grade, level, cut, fill, drain, build, maintain, repair, and rebuild a road or highway and such culverts, bridges, turnouts, retaining walls, or other appurtenant structures as may be necessary, on, over, and across the land embraced within the right-of-way, the center line of which is described as follows:
