Contiguous to Tract NBV-13: 78 red fir trees located outside the limits of the above described right of way through said Tract NBV-13 and on land described herein belonging to defendants and adjacent to said right of way of petitioner, duly designated as danger trees by two blazes on the side of the tree next to said right of way, one blaze being on the trunk of each tree just above the ground, and the second blaze being on each tree about four feet above the ground and each tree branded with the letters BP, all of said trees being at the locations set forth on sheet numbered 5 in schedule hereto attached marked "Exhibit B" and by this reference made a part hereof, the distances set forth in said schedule being the distances respectively from the northerly or southerly boundary line of said right of way.

Contiguous to Tract NBV-15: 5 red fir trees located outside the limits of the above described right of way through said tract NBV-15 and on the land described herein belonging to defendants and adjacent to said right of way of petitioner, duly designated as danger trees by two blazes on the side of the tree next to said right of way, one blaze being on the trunk of each tree just above the ground, and the second blaze being on each tree about four feet above the ground and each tree branded with the letters BP, all of said trees being at the locations set forth on sheet numbered 6 in the schedule hereto attached marked "Exhibit B" and by this reference made a part hereof, the distance set forth in said schedule being the distance from the southerly boundary line of said right of way.

Contiguous to Tract NBV-17: 60 second growth red fir trees located outside the limits of the above described right of way through said Tract NBV-17 and on the land described herein belonging to defendants and adjacent to said right of way of petitioner, duly designated as danger trees by two blazes on the side of the tree next to said right of way, one blaze being on the trunk of each tree just above the ground, and the second blaze being on each tree about four feet above the ground and each tree branded with the letters BP, all of said trees being at the locations set forth on sheet numbered 7 in the schedule hereto attached marked "Exhibit B" and by this reference made a part hereof, the distances set forth in said schedule being the distances respectively from the northerly or southerly boundary line of said right of way.

3. Possession of such of the above described property as is now vacant, unoccupied and uncultivated is given to the United States, to the extent of its rights under the perpetual easement and right-of-way hereinbefore described, on the 25th day of February, 1942, and possession of the remainder of said property on or before the 28th day of February, 1942.
