Know all men by these presents, That William Logan Robertson in consideration of Ten and 00/100 Dollars, to him paid by Crystal Irene Robertson, his wife does hereby grant, bargain, sell and convey unto said Crystal Irene Robertson, his wife her heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances situated in the County of Skamania, Washington bounded and described as follows, to-wit:

The West One-half (W $\frac{1}{2}$) of the Southwest Quarter (SW $\frac{1}{4}$) and the Northeast Quarter (NE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Thirty-five (35) Township Two (2) North Range Five (5) East of the Willamette Meridian, all of the above described property being situated in the County of Skamania, State of Washington.

The within deed is given by William Logan Robertson to his wife, Crystal Irene Robertson for the purpose of divesting the real estate herein described from any or every claim or demand as community property, and this instrument is intended to vest the above described property in the grantee as her separate property, all in accordance with the provisions of Section 10572, Remington's Revised Statutes of Washington.
