Shea and Madalien Shea, husband and wife, contract purchasers, for and in consideration of the sum of Twenty Five Dollars (\$25.00), cash in hand paid, receipt of which is hereby acknowledged, do hereby grant and convey unto the United States of America and its assigns a permanent easement and right-of way approximately 14 feet in width, with such additional widths as are necessary to provide for cuts, fills, and turnouts and for curves at the angle points, all over and across the lands of the undersigned in
