For and in consideration of the premises hereinafter set forth, we the undersigned, E. A. Casper and Teresa Casper, husband and wife hereby sell and convey to P. Q. Rothrock and Minnie M. Rothrock, husband and wife, as joint tenants, all our right, title and interest in and to that certain real property situate in the County of Skamania, State of Washington, described as follows, to-wit:

The East $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ and the East $\frac{1}{2}$ of the Southeast $\frac{1}{4}$ of Section 20, Township 3 North of Range 10. East of the Willamette Meridian, hereby relinquishing and reconveying to said grantees all the right title and interest which we received by the terms of a certain contract dated the 26th day of September, 1939 (1939) by the terms of which said contract the said grantees herein agreed to sell to us the aforesaid real property and Lots 3 and 4, since conveyed by all of us to the Broughton Lumber Company, as to nearly all of said Lots,
