## TREASURER'S DEED

THIS INDENTURE, made this 26th day of October, 1942, between John C. Wachter, as Treasurer of Skamania County, State of Washington, the party of the first part, and Alma E. Shipley party of the second part.

WITNESSETH, That Whereas, at a public sale of real property, held on the 2nd day of November, A. D. 1932, pursuant to an order of the Board of County Commissioners of the County of Skamania, State of Washington, duly made and entered, and after having first given due notice of the time and place and terms of said sale, and, whereas, in pursuance of said order of said Board of County Commissioners, and of the laws of the State of Washington, and for and in consideration of the sum of One Hundred Fifty and no/100 Dollars, lawful money of the United States of America, to me in hand paid, the receipt whereof is hereby acknowledged, I have this day sold to Alma E.
