Golden and Pearl Golden, contract purchasers, husband and wife now and at the time of entering into the contract, have granted, bargained and sold and by these presents do hereby grant, bargain, sell and convey unto the United States of America and its assigns, a permanent easement and right-of-way approximately 14 feet in width, with such additional widths as are necessary to provide for cuts, fills and turnouts and for curves at the angle points, all over and across the hands of the undersigned in the
