To Have and To Hold, the said premises, with all their appurtenances, unto the said party of the second part and to her heirs and assigns forever; and the said Elsie Beckon party of the first part, for herself and for her heirs, executors and administrators, does hereby covenant to and with the said party of the second part her heirs and assigns that she is the owner in fee simple of said premises and that they are free from all encumbrances whatsoever, and that she will warrant and defend the same against all lawful claims whatsoever.
