M. Wright above mentioned, together with easement for pipe line from the springs and intake located on said conveyed tract to grantors retained property along the following described course, to-wit. Commencing at the wood water tank or reservoir near the springs on the above conveyed tract, thence S 22° 27' E 56 feet, thence S 17° 17' W 40.4 feet, thence N 89° 57' W 163 feet to west line of said conveyed tract, and also from said tank to intake at springs.
