To Have and To Hold the above described and granted premises unto the said Carl E. Wicher and Edith L. Wicher, their heirs and assigns forever.

The grantor herein does covenant to and with the above named grantees, their heirs and assigns, that she is lawfully seized in fee simple of the above granted premises, and that the above-granted premises are free and clear of all encumbrances and liens except such encumbrances and liens as have been permitted or created by said grantees since July 8, 1941, the date of a certain contract between the parties hereto, and that grantor, her heirs, executors and administrators shall warrant and forever defend said granted premises and every part and parcel thereof, against the lawful claims and demands of all persons whomsoever, except as to said encumbrances above mentioned.
